Re: Comments to Consider During Hearing on ESRD Policies

Dear Senator Grassley:

The Renal Support Network (RSN) is a nonprofit, patient-focused, patient-run organization that strives to help patients develop their personal coping skills, special talents, and employability by educating and empowering them, as well as their family members, to take control of the course and management of the disease.

People who have chronic kidney disease are very grateful for the ESRD program and how it has helped continue our lives. With the upcoming hearing on quality of dialysis care and the discussion that will ensue, we would like to bring up a few points to consider:

1. Ensure that people who have ESRD have access to quality care, especially in rural and inner-city areas.
2. Be certain that policies implemented improve the quality of care and that measures are in place to ensure this process.
3. Allow patients to have a choice as to where to dialyze and the different modality options (including home therapies). Offer equal incentives to both small and large providers to stay a viable business.
4. Provide reimbursement structures that include the ability for new innovative technologies to emerge that will improve our overall well-being.

CMS has brought forth several initiatives to improve care such as: Fistula First, Dialysis Facility Compare Website, Know Your Numbers, and the Clinical Performance Measures, to name a few.



You are well aware of the Kidney Care Quality and Improvement Act of 2005 that address other concerns of the kidney community.

There is much to be learned about the diverse kidney patient population, and RSN appreciates Congress taking the time to figure out ways to improve the care and the access to care for all patients. As you seek ways to improve the ESRD program with alternative payment methods, the patients ask that you please allow the kidney community (including the patients) to be part of the process.
